Mayor McFetridge reviewed the 2025-2026 Budget: General Fund will use \$49,109.00 from Fund Balance to balance the budget Water Fund will use \$43,313.00 from Fund Balance to balance the budget Sewer Fund will use \$70,590.00 from Fund Balance to balance the budget The tax rate will remain the same at \$4/K

Village Residential & Commercial water rates increased from \$7.00/K gal to \$7.55/K gal Town Residential & Commercial water rates increased from \$6.25/K gal to \$6.45/K gal.

Village Residential sewer rates increased from \$6.00/K gal to \$6.75/K gal Village Residential sewer service fees increased from \$37.50/Q to \$47.50/Q Village Commercial sewer rates increased from \$8.00/K gal to \$9.00/K gal Village Commercial Sewer minimum service fees increased from \$65.00/Q to \$70.00/Q Outside Village sewer rates increased from \$13.28/K gal to \$15.00/K gal Town Residential & Commercial Sewer rates increased from \$13.28/K gal to \$15.00/K gal. Mayor McFetridge is working on the Comp Plan with the engineers and the Town of Champlain. They are making progress and a second community meeting will be held soon.

She attended the Chamber of Commerce St. Patrick's Day breakfast, recognizing the citizen of the year, Bill Meyers of Casella Systems.

She travelled to Albany with several other North Country women to attend a Celebration of Women's History month.

She met with Leanne Yelton from Clinton Community College to discuss ways the Village might connect with the college and her efforts in theatre & the arts. We will offer Shakespeare in the Park in August. She attended Zoom meetings regarding electric rates and Clean Energy programs.

Slow Art Day was on April 5<sup>th</sup>. This yearly event and has been well supported for almost 10 years. . The County was awarded a grant for Ash tree removal last year. The County Soil & Water office has not received an update on the dispersal of those funds.

#### REPORT FROM SUPERINTENDENT

#### WATER:

• Monthly water readings found a few high readings that we followed up on.

#### STREETS:

- Dug ditches and culverts to help with water flow.
- Cold patched some potholes
- Cleaned up trees that came down during high winds
- Started spring cleanup of sod, sticks, stones, trash and shopping carts.
- Cut trees that needed to be removed.

#### **SEWER**

- We had a pump issue at the wastewater plant. We changed the pump and will send it out to be rebuilt. We had to get a tech here to work on the panel to get it going.
- We are still having an issue with relay at the wastewater plant. It trips out the Huber screen. Still working on getting this fixed.
- One blower is down at the sewer plant. We are troubleshooting this with tech support. We hope to get this fixed soon, or will need to get a tech to travel to us.

# MISC.

- The 2010 Peterbilt had the oil pan changed, serviced, front axel seal, hydraulic filter, air dryer filter, new air relief valve that was leaking. Ordered a new rear tire. We are working on an electrical issue and will need to get it inspected once everything is repaired.
- We have an air leak on the air dryer on our 2021 Peterbilt. We will wait until snow is over to take it out of service and repair.
- We have a lot of bad trees in the Village, mostly ash, that have died and are dangerous. These will need to be removed. We will continue taking the trees down as time allows. Some we cannot take down as they are around wires and too tall to reach.
- We changed the brush wafers on our sweeper and are getting ready for spring sweeping after the weather breaks and chance of sanding is over.

Contractors for the Water Line project should be back at the end of the month to finish up. They need to do a cut in on Rt. 9 for Cane St. Asphalt will be ready close to the beginning of May for patching that. The cleanup, sidewalks and top soiling should be done. It's been nice not to have water breaks regularly now.

# **Purchase Requisition**

Pressure Reducing Valves Ross Valve 2 @ \$2,327.00 + shipping

In doing pressure vault maintenance, 2 vaults will need valves changed. The pressure reducing vaults came from Ross and Ross is the sole supplier of the valves. Supt. Jolicoeur will try to rebuild the old valves and keep as backup. He is looking for up to \$5,000.00 for the purchase of 2 valves, strainer screen and shipping.

They offer OSHA training, leak detection testing and other extras. We have to buy materials directly from EJ Prescott. This renews annually.
